## PURPOSE

The function of the Sliding Fee Scale Program – is utilized to ensure that CCBHC individuals have access to Integrated Services of Kalamazoo (ISK) services regardless of their ability to pay and to provide instruction for charging individuals served through the utilization of a sliding fee discount program, The sliding fee discount program is to be utilized for those individuals who have no means or limited means to pay for their services (underinsured or uninsured). The following services often require daily and/or weekly contacts and will not be subject to daily services requiring a potential payment under the sliding fee scale: Skill Building, Supported Employment, Assertive Community Treatment and Home Based.

## DEFINITIONS

#### **Sliding Fee Discount Program**

A schedule of discounts in charges based on the federal poverty guidelines as established by the U.S. Department of Health and Human Services. This discount is calculated using household income and size.

## POLICY

Persons with a Mental Illness or Substance Use diagnosis receiving CCBHC eligible services will not be denied services based on their ability to pay, in accordance with the requirements of the federal sliding fee discount program under 42 USC 254g and related guidance. Eligibility for the sliding fee discount program is based solely on family size and

income in accordance with the most current federal poverty guidelines published annually in the federal poverty guidelines as established by the U.S. Department of

Health and Human Services. Persons served shall be fully informed of the cost of services and how they are financed. Each CCBHC eligible individual receiving services shall be offered information on the ISK sliding fee discount program. A consumer will not be denied services because of an inability of responsible parties to pay for services.
